16.Multidisciplinary / interdisciplinary

The University offers academic exposure by cutting an edge in research and development in Sports Sciences. The campus is provided with e-resources, specialised laboratories and ICT facilities. Interdisciplinary approach is maintained in the curriculum, teaching learning and research activities in this institution. Multidisciplinary subjects are offered through the introduction of Generic Courses. The students have the options of taking up subjects other than their own discipline. Through this, the students' development takes place in a holistic manner. The students get equipped with knowledge, skills, attitudes and values which paves way for better employment opportunities.

17.Academic bank of credits (ABC):

The University would take the initiatives to fulfil the requirements of the Academic Bank of Credits. The University has not registered for the implementation of Academic Bank of Credits. The curriculum of each program is designed as per the objectives of the institution. The curriculum is authenticated by the members of the Board of Studies as it is in line with accrediting bodies viz., UGC, AICTE, NCTE and DEB etc. The curriculum comprises of Core Courses, Discipline Specific Elective, Generic Elective and Ability Enhancement Courses, which are periodically revised by the members of the respective faculties. Faculty members of the University are encouraged to develop and design their own curriculum and employ different pedagogical approaches such as SMART Classrooms, Group

The classes for all the courses were conducted through online and offline mode based on the time table prepared by the course coordinators for 6 month period. After completion of the classes the assignments were collected by the course coordinators and the model examination were also conducted for all the courses. We are yet to complete the semester exam. Efforts have been taken to conduct examination and for further process.

19. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Prime Minister (PM) Narendra Modi has led from the front by focusing on traditional knowledge systems. In November 2014, the government set up a separate ministry of Ayush to ensure the seven traditional systems of health care, including ayurveda and yoga, are leveraged adequately in our public health care systems. By December 2014, the United Nations passed a resolution declaring June 21 as International Day of Yoga with 177 nations co-sponsoring the resolution. In June 2016, while addressing a joint session of the United States Congress, PM Modi stated that India did not claim intellectual property rights on Yoga, highlighting that traditional Indian knowledge systems have always been open and accessible to all. In several public forums since then, the PM has categorically said yoga is India's gift to the world for health and peace. The United Nations General Assembly has declared June 21 as International Day of yoga. In addition, declaration of yoga as an intangible cultural heritage by UNESCO has helped to build yoga as an international cultural brand name.

Modern medical advancements provide the rationale for integration of various traditional healing techniques like Yoga, Naturopathy, Ayurveda, Siddha and Music to promote health, healing and longevity. Government of India is currently promoting indigenous systems of health in an active manner through Ministry of AYUSH. The limitation of modern medicine in managing stress induced psychosomatic, chronic illnesses is the strength of these traditional healing systems and hence a holistic integration of both systems enables best quality of patient care.

In the Indian epic, the Bhagavad Gita, yoga is described as a meditative means to overcome suffering through Samadhi (concentration), find inner peace and salvation and to experience enlightened consciousness. In fact, each of the 18 chapters of

the Bhagavad Gita is considered as a different yoga. It is essential to understand that the true meaning of yoga lies in its cultural, religious and philosophical moorings rather than viewing it as a set of physical exercises and body postures. As an ancient knowledge system of Yoga that has come down over generations, there is no better moment than this to recognise the power of Yoga. Crafting a value education package comprising yoga and its benefits is called for to promote holistic personality development, healthy lifestyle and at a different platitude, promote Indianness and social leadership.

In TNPESU the true essence of yoga is incorporated through the Department of Yoga so that the students are ingrained with its historical and cultural legacies, in a timeline. The theory course curriculum includes Vedic concepts and all the important Yogic classical texts such as Patanjali Yoga Sutra, Bhagavad Gita, Hatha Yoga Pradipika, Upanishads and Yoga Vasistha. The department adopted innovative ways to ensure the healthcare benefits of yoga in boosting immunity of the human body, especially at the testing times of pandemic lockdown. The courses were continued and conducted in the offline mode during COVID time. Yoga as therapy takes a holistic approach considering each person as an individual. In situations in which disease is established, yoga is performed only as an adjunct to medical treatment. To practice yoga safely and effectively, learning yoga with a trained professional is necessary. In the Yoga therapy course, students are learning the therapeutic techniques of Yoga for several diseases. Yogic exercises are not limited to use with disease states. They are highly recommended for healthy individuals as well. So that all the students are receiving regular practical training in Yoga. The Yoga department course curriculum provides the complete theory and practical training of yoga as well as Yoga Therapy to the students.

We have also conducted various Faculty Development programs, Workshops, Conferences, Webinars, and Competitions during the period from July 2020 to Dec 2021 through online and offline modes to promote Yoga and to bring awareness about yoga among the public to enhance overall well-being and quality of life.

20. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

The University adheres to the Choice Based Credit System and Out Based Education System. The Program Objectives (POs), Program Specific Objectives (PSOs)) and Course Objectives (Cos) of all disciplines with all the courses have focus on relevant

development and their needs. The POs, PSOs and the Cos of each course and program are well defined by the faculty members of the Department, which is approved by the members of the Board of Studies. These objectives are attained through well-defined methods such as Continuous Assessments comprising of Internal Tests, Class Performance activities and External Examination. These outcomes are published in the University website for the awareness of all the stake holders. The course outcomes are made known to the students by Heads of the Departments on the Freshers' Induction Program. The programme outcomes have contributed towards students' progression in terms of higher education and job opportunities.

21.Distance education/online education:

The school of Distance Education (SDE) OF Tamil Nadu Physical Education and Sports University was established in the year 2007 with a vision to impart higher education to the students who, due to various circumstances, cannot undergo face to face education. Over the years the School of Distance Education turned as a main focus for students who cannot afford or not willing to join colleges or who are employed or who are seeking additional qualification. There is a vast array of courses that are offered in the SDE at different levels such as Certificate, Undergraduate, Post Graduate, Diploma, PG Diploma and Lateral courses. In order to facilitate the independent study, all the learning resources of the SDE are prepared meticulously in self learning format with subject experts. The Personal Contact Programs are handled by experienced faculties drawn from our University departments and affiliated colleges of our University. Some of the highly technical and practical oriented courses are handled by the faculties who have vast knowledge in these subjects. Technical support, smart class rooms and ICT support laboratories will help the candidates to gain more competence and prepare to face the job market.

All the programs being offered through Distance mode have been approved by University Grant Commission / Distance Education Bureau. Among which few yoga and sports coaching related programs are considered under partially vocational type which pave a path to get wonderful job opportunities for the takers. Organizing yoga programs, conducting workshops and seminars to inculcate the knowledge of yoga and observing international yoga day are considered as best practices followed by School of Distance Education.

The courses offered by School of Distance Education will quench the thirst of physical Education Personals, Medical professionals, Teaching Community, Officers, Administrators and even more common public.

 - This University Library has purchased updated version of Library Automation Software during the year 2016. The updated version consists of the following modules, Acquisition Control System, Bibliographic Control System, Circulation Control System, Serials Control System, Online

Innovative Laboratories for Dissemination of Sports Knowledge

Background

During the previous decade, Indian sports have experienced amazing growth. Despite the efforts of the Governments and respective sports federations in developing sports in India, significant progress has not been made at the international level due to a lack of access to the newest technology and expertise by players and coaches. As a result, it is critical to teach the latest sports technology to athletes and coaches so that they can improve their sports performance by modifying their regular sports training.

Innovative Laboratories

To try to close the gap, the University has created the following unique sports laboratories with the goal of distributing sports information to the sport's stakeholders:

- 1. Computerized Low-Speed Subsonic Wind Tunnel Laboratory to analyse the influence of aerodynamic forces and wind impacts on sports applications.
- 2. Computational Sports Technology Laboratory uses CAD and Ansys Workbench to design and create sports items and equipment. For match analysis, DartFish is employed.
- 3. Center of Excellence in Biomechanics for biomechanical assessment of athletes from high school to elite levels in order to improve sports performance, avoid injuries and identify talents.
- 4. Exercise Physiology laboratory is used to determine the functional capabilities of athletes' bodily systems.
