ORDER:

Hon'ble Minister (Sports and Youth Welfare) has made an announcement during the demand for the year 2014-15 that "Hon'ble Chief Minister has ordered Rs.44 lakhs for construction of a canteen building with facilities such as dining hall, store, kitchen, toilet etc., in Tamil Nadu Physical Education and Sports University".

2. In the letter read above, the Vice Chancellor (O), Tamil Nadu Physical Education and Sports University has sent the proposal along with Rough Cost Estimate for construction of a canteen in Tamil Nadu Physical Education and Sports University. The rough cost estimate was prepared based on the Plinth Area Rate of 2013-2014 with an escalation of 10% for the year 2014-2015. The rough cost estimate was approved by the Chief Engineer PWD, Technical Education Circle, Guindy, Chennai-600025. The estimate works out to Rs.44.00 lakhs.

3. The Vice Chancellor (O), Tamil Nadu Physical Education and Sports University has stated that the University is situated at Melakottaiyur village in 125 acres. At present the University is not having a building for canteen. It is functioning in a small area under the staircase of the academic building with minimum facility to prepare only tea and coffee. The parents, visitors, research scholars and students of regular and distance education programme are facing difficulty as they have to go more than 3 kilometers for taking meals and other refreshments. It is mandatory to construct a separate canteen building with the size of 15x10 meters with facilities such as dining hall, store, kitchen, toilet etc., with the prefabricated structure with light roof materials in the university campus.

Hence, the Vice Chancellor (O), Tamil Nadu Physical Education and Sports University has requested the Government to sanction Rs.44 lakhs for construction of a canteen building in Tamil Nadu Physical Education and Sports University campus.

4. The Government after careful examination, sanction a sum of Rs.44,00,000/- lakhs (Rupees forty four lakhs only) towards construction of a canteen building in the Tamil Nadu Physical Education and Sports University.

5. The expenditure sanctioned above shall be debited to the following head of account:-

"2204 00 Sports and Youth Services – 101 Physical Education – I Non Plan – AB Tamil Nadu Physical Education and Sports University – 09 Grants – in – aid – 02 Grants for Creation of Capital Assets" (DPC 2204 00 101 AB 0924)

6. The expenditure sanctioned para 4 above shall constitute an item of 'New Service' and approval of the Legislature will be obtained in the due course of time. Pending approval of the Legislature, the expenditure shall initially be met by an advance from the Contingency Fund, orders regarding which will be issued by the Government in Finance (BG-I) Department based on the application from the Registrar (i/c), Tamil Nadu Physical Education and Sports University in the prescribed format along with a copy of this order. He is also requested to send necessary draft explanatory notes for inclusion of the expenditure in Supplementary Estimate for the year 2014-15 to Finance (BG-I) Department without fail.

7. The Under Secretary to Government, Youth Welfare and Sports Development Department is authorized to draw and disburse the amount to the Registrar i/c, Tamil Nadu Physical Education and Sports University.

8. The Registrar i/c, Tamil Nadu Physical Education and Sports University, Chennai shall send the utilization certificate to the Government in due course.


