

The mission of the e-Library is to provide an effective and efficient information infrastructure to the Central Library for providing access to the current and relevant on-line resources, fostering an environment and culture which is conducive to advancing the usage of e-learning resources for enabling stakeholders to contribute in the global society. It also aims to conduct need based information literacy programs for the benefits of the students, faculty, staff and other associates.

## ORDER:

In the Government order first read above, administrative sanction was accorded for a sum of Rs.13,12,20,000/- over a period of two years and financial sanction was accorded for Rs.10.00 crore in the financial year 2017-2018 for the establishment of Centre of Excellence in Sports Biomechanics in Tamil Nadu Physical Education and Sports University campus.

- 2. In the Government order second read above, orders were issued to construct the building for Centre of Excellence in Sports Biomechanics at Tamil Nadu Physical Education and Sports University at a cost of Rs.7,02,00,000/- and to purchase sports equipments at a cost of Rs.6,07,00,000/- subject to incur the expenditure within the amount of Rs.13.122 crore sanctioned already in the Government Order first read above.
- 3. In the letter third read above, the Registrar, Tamil Nadu Physical Education and Sports University has stated that the construction of the building

has been commenced and it would be ideal to procure the equipment during the course of construction of building due to the following reasons:

- i. The channels of power cables and data cables of the 3D motion analysis camera has to be fixed during the construction phase itself.
- ii. The force platform fixation on the ground floor and the channels of cabling can only be fixed during the course of construction.
- iii. The equipment vendor, building contractor and the final flooring bidder will have to sit for a discussion to set up the whole equipment unit in tandem.

Hence, it is ideal to process the procurement of equipment at the earliest.

- 4. The Registrar, Tamil Nadu Physical Education and Sports University has therefore requested the Government to release the remaining amount of Rs.3,12,20,000/- as second instalment so as to enable them to process the procurement of equipment and make the unique Sports Biomechanics laboratory functional and meaningful.
- 5. The State Planning Commission has also recommended the proposal vide Lr.No.5475/SPC(PC)2016 Dated 27.02.2017 for release of Rs.3,12,20,000/during the second year towards establishment of Centre of Excellence in Sports Biomechanics in Tamil Nadu Physical Education and Sports University campus.
- 6. The Government after careful consideration, sanction a sum of Rs.3,09,00,000/- (Rupees Three crore and nine lakh only) in the financial year 2019-20 as second and final instalment towards establishment of Centre of Excellence in Sports Biomechanics in the Tamil Nadu Physical Education and Sports University campus under Tamil Nadu Innovation Initiatives (TANII).
- 7. The expenditure sanctioned at para-6 above shall be debited under the following head of account:-

Pending provision of such funds in RE/FMA 2019-20, the Under Secretary to Government, Youth Welfare and Sports Development Department is authorized to draw and disburse the amount sanctioned in para 6 above to the Registrar, Tamil Nadu Physical Education and Sports University. This expenditure should be brought to the notice of the Legislature by Specific Inclusion in the Supplementary Estimates 2019-20. The Registrar, Tamil Nadu Physical Education and Sports University is directed to include the expenditure sanctioned above, while sending the Budget proposal for RE/FMA 2019-20 and also to send necessary Explanatory Notes for including the above expenditure in the Supplementary Estimates 2019-20 to Finance (BG-I) Department without fail.
- 10. The Registrar, Tamil Nadu Physical Education and Sports University shall send the Utilization Certificate to the Government in due course.



## ORDER:

In the Government Order 1<sup>st</sup> read above, administrative sanction was accorded for Rs.13,12,20,000/- (Rupees Thirteen crore twelve lakh and twenty thousand only) for establishment of Centre of Excellence in Sports Biomechanics in the Tamil Nadu Physical Education and Sports University.

- 2. In the letter 2<sup>nd</sup> read above, the Registrar, Tamil Nadu Physical Education and Sports University has stated that the original proposal for construction of Centre of Excellence was submitted in the year 2016-2017 and the building cost was roughly estimated at Rs.6.00 crore. The inclusion of centage charge and escalation of construction cost for more than a year resulted in increase in the rough cost estimate to the tune of Rs.8.06 crore. If certain provisions such as front elevation, power room and fencing were restricted, the total cost of the building would come down to Rs.7,02,00,000/- without centage charges.
- 3. The Registrar, Tamil Nadu Physical Education and Sports University has also stated that earlier the equipments for the proposed Centre of Excellence

were estimated at a cost of Rs.7.122 crore. As there was increase in the cost of construction of building, it has been proposed to purchase the sports biomechanics equipments which are required immediately to bring out the project into functioning and hence the estimate for purchase of equipments has been reduced to Rs.6.07 crore instead of Rs.7.122 crore. He has added that no additional funds have been sought for and the Centre of Excellence in Sports Biomechanics is proposed to be constructed within the amount already sanctioned only.

- 4. The Registrar, Tamil Nadu Physical Education and Sports University has, therefore, requested orders on the following:
  - for construction of the building for Centre of Excellence in Sports Biomechanics at a cost of Rs.7,89,75,000/- (including centage charges)

ii. to purchase sports equipments at a cost of Rs.6,07,00,000/-

- iii. to grant exemption from payment of Rs.87,75,000/- being centage charges.
- 5. The Government after careful consideration, issue orders to construct the building for Centre of Excellence in Sports Biomechanics at Tamil Nadu Physical Education and Sports University at a cost of Rs.7,02,00,000/- (Rupees Seven crore and two lakh only) and for the purchase of sports equipments at a cost of Rs.6,07,00,000/- (Rupees Six crore and seven lakh only), subject to incur the expenditure within the amount of Rs.13.122 crore sanctioned already in G.O.(Ms).No.35, Youth Welfare and Sports Development (YW2) Department, Dated 31.7.2017.
- 6. The Government also accord exemption from payment of Rs.87,75,000/- (Rupees Eighty seven lakh and seventy five thousand only) being centage charges at 12.5% of Rs.7,02,00,000/-.
- 7. This order issues with the concurrence of Finance Department vide its U.O.No.2085/Fin(Edn-I)/2019, Dated 23.01.2019.

## ORDER:

In the letter read above, the Registrar, Tamil Nadu Physical Education and Sports University has stated that teacher trainer in Physical Education must equip themselves during the course of study in the key areas of Teaching, Testing and Training. To equip them in the above areas, apart from traditional methods, they need a high level of scientific support to meet out the demands of modern education. A well developed pedagogical approach enhances the potential of the teacher trainers. A pedagogical laboratory needs to be set up for the benefit of teacher trainers in physical education with modern equipments such as teaching aids, audio-visual aids, testing and training gadgets.

- 2. The Registrar, Tamil Nadu Physical Education and Sports University has therefore requested the Government for establishment of Pedagogy Laboratory for Teaching, Testing and Training in Physical Education at an estimated cost of Rs.25.00 lakh under Tamil Nadu Innovation Initiative (TANII).
