E-Governance is the use of information and communication technologies (ICT) in organizations to provide user services, to improve work efficiency and to promote democratic values. It is being used as a platform for efficient, transparent and timely delivery of services to all the stakeholders. In essence the purpose of e-governance is to bring transparency and efficiency in the working of an organization. This urge for transparency and efficiency is derived by the demand of ever increasing aspirations of information age.

Tamil Nadu Physical Education and Sports University, Chennai is trying its best to keep pace with the recent applications of e-governance in terms of various functions being performed digitally through internet and networking.

The necessary infrastructure is provided partly by the State Government, partly by the University and other funding agencies through development and project grants. Most of the staff and students use smart phones to utilize the benefits of modern day technologies available in the field of higher education.

Chennai 600 127 AnITCeII has been established in the University to monitor and regulate smooth functioning of computer systems and to address all IT related issues so that maximum benefits could be ensured out of them. Students and staff-members are provided help-desk pattern assistance in case of software and online portal related issues.

## **Finance and Accounts**

As a basic ingredient of e-governance concept and as per instructions of the government, all kind of financial transactions has become **cashless**. The salaries of employees including examination remunerations are paid online through NEFT/RTGS and rarely by cheques. Not only is that, the payment of scholarships and all purchasing transactions are executed necessarily cashless to maintain **transparency and financial accountability** in the system.

# Students' Admission and Support

University admission to all courses has been carried through online process and it is managed & regulated by **National Informatics Centre, Government of India** through University's webportal www.tnpesu.edu.in since 2018-19. From 2018-19, admission and and activities has also been initiated **online** through a software system developed exclusively for TNPESU, Chennai.

Online admission and support activities include the followings as such-

- Disclosure of admission rules/schedule on web page
- Verification of documents, payment of fees& other admission formalities
- Preparation & publication of admission rolls as per rules and regulations of UGC/State Government norms.
- Admission related data management through web-based MIS & e-mails
- Disclosure of students-centric information/data/materials on website
- Wi-Fi campus & Availability of internet/e-resources in library
- ICT based teaching in Multimedia classrooms
- Maintenance of students' attendance in webbased formats
- Online hall ticket, payment of exam fees and declaration of results

Above digital functions are realized online through internet with support of ICT based infrastructure available in the University.

# **Examination System**

To promote autonomy in Controller of Examination section, there is a fully computerised exam cell which conducts exams, maintains curriculum and publish results online for different courses/programs. Results processing is realized through customizable software with stringent security features (developed by NIC, India).
