MURUGUVALAVAN**, as **LECTURER CUM MEDICAL OFFICER** in the University Centre in the scale of pay of Rs. 8000-275-13500/- with admissible allowances. His/Her pay will be fixed as per norms and intimated separately.

The terms and conditions are as follows: -

1. He/She will be on probation for a period of two years from the date of joining duty, in the first instance and is subject to the extension for a further period, if deemed necessary.
