The above matter was placed before the 32nd Meeting of the Finance Committee held on 22.11.2018 wherein the members of the Finance Committee required the reasons for proposing printing study materials for 3 years in one stretch. The Registrar replied that the syllabus is common for all the three years and it will be cost beneficial, if we print huge number of books in one time. The Secretary to Government (Expenditure), Finance department observed that demand cannot be predicted for future period and it will be more difficult to store books for three years which required space, protection from damages etc. He further observed that the cost benefits will be less when compared to the above problems.

The Committee requested to explore the possibilities of getting the books printed by Tamil Nadu Text Book Corporation Ltd. also and directed the University authorities to furnish the cost benefits ie printing books for 3 years at one time and printing of books each year based on demand. Accordingly, the Director, School of Distance Education has furnished the details.

"The Director, School of Distance Education has submitted three quotations received from the printers [Towards working purpose]. As per the quotations, the rates for printing of books are as follows

For printing 100 nos of books each 150 pages	Re.1.435 per page	
For printing 300 nos of books each 150 pages	Re.0.64 per page	
For printing 600 nos of books each 150 pages	Re.0.44 per page	
For printing 1000 nos of books each 150 pages	Re:0.378 per page	

More than 1000 books are required, for courses like Yoga and for all other courses the approximate requirement will be 300 to 600 books for three years.

As directed by the Finance Committee, Text Book Corporation will be approached for printing of books. On receipt of reply from them, we may consider for placing of orders with Text Book Corporation (or) to print books for 3 years in one time by following due
