### ORDER:

In the letter read above, the Registrar, Tamil Nadu Physical Education and Sports University has stated that teacher trainer in Physical Education must equip themselves during the course of study in the key areas of Teaching, Testing and Training. To equip them in the above areas, apart from traditional methods, they need a high level of scientific support to meet out the demands of modern education. A well developed pedagogical approach enhances the potential of the teacher trainers. A pedagogical laboratory needs to be set up for the benefit of teacher trainers in physical education with modern equipments such as teaching aids, audio-visual aids, testing and training gadgets.

2. The Registrar, Tamil Nadu Physical Education and Sports University has therefore requested the Government for establishment of Pedagogy Laboratory for Teaching, Testing and Training in Physical Education at an estimated cost of Rs.25.00 lakh under Tamil Nadu Innovation Initiative (TANII).

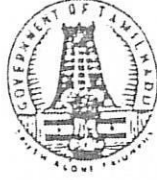

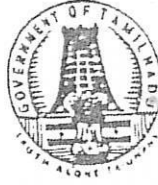

### ORDER:

The Hon'ble Chief Minister has announced under Rule 110 of the Tamil Nadu Legislative Assembly Rules that Centre of Excellence for Badminton Academy will be established at Tamil Nadu Physical Education and Sports University at a total cost of Rs.10.00 crore.

2. Based on the above announcement, the Registrar, Tamil Nadu Physical Education and Sports University has requested the Government to accord necessary administrative and financial sanction to the tune of Rs.1,600.00 lakh based on the detailed estimate prepared by the Technical Education Division of Public Works Department towards establishment of Centre of Excellence for Badminton Academy at Tamil Nadu Physical Education and Sports University. He has also requested to sanction 50% of amount i.e. Rs.800.00 lakh during the academic year 2018-19 for taking up construction works and to put into use the Centre of Excellence and the balance amount of Rs.800.00 lakh in the subsequent academic year 2019-2020. Moreover, the Registrar, Tamil Nadu Physical Education and Sports University has requested to waive the centage charges at 12.5% from the estimate amount.

3. The Government after careful consideration, accord administrative sanction for a sum of Rs.13.33 crore (Rupees thirteen crore and thirty three lakh only) for establishment of Centre of Excellence for Badminton



Academy at Tamil Nadu Physical Education and Sports University, reducing the amount proposed for lighting to achieve 500 Lux instead of 1000 Lux and including provision for synthetic mat over wooden flooring in play area and also with certain restrictions made in the Detailed Estimate. The Government also accord financial sanction for a sum of Rs.5.00 crore (Rupees Five crore only) for the year 2018-19 and waive centage charges. 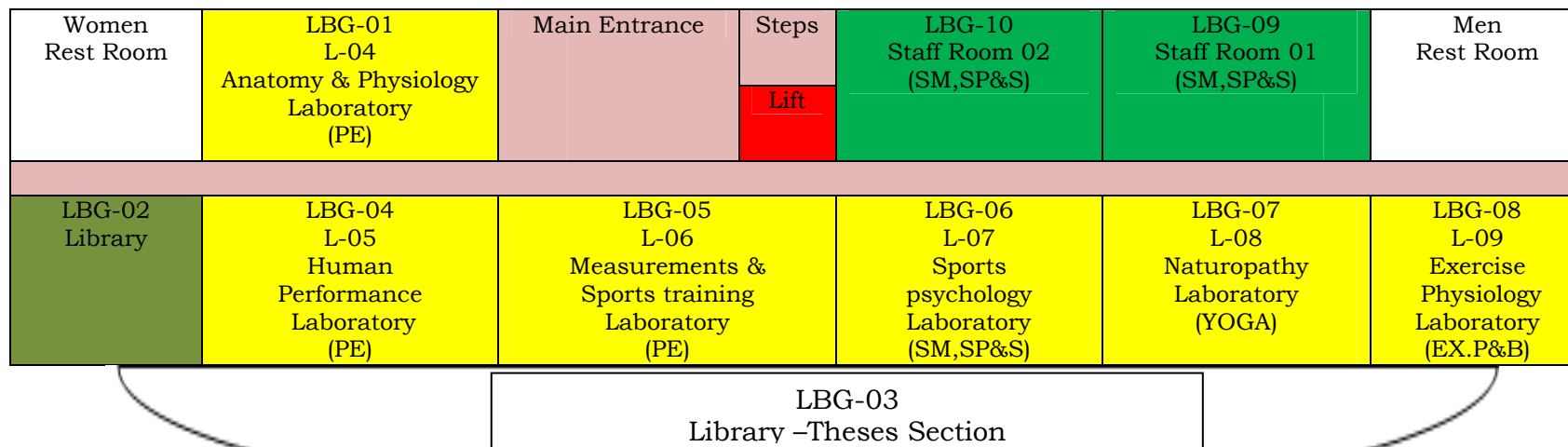

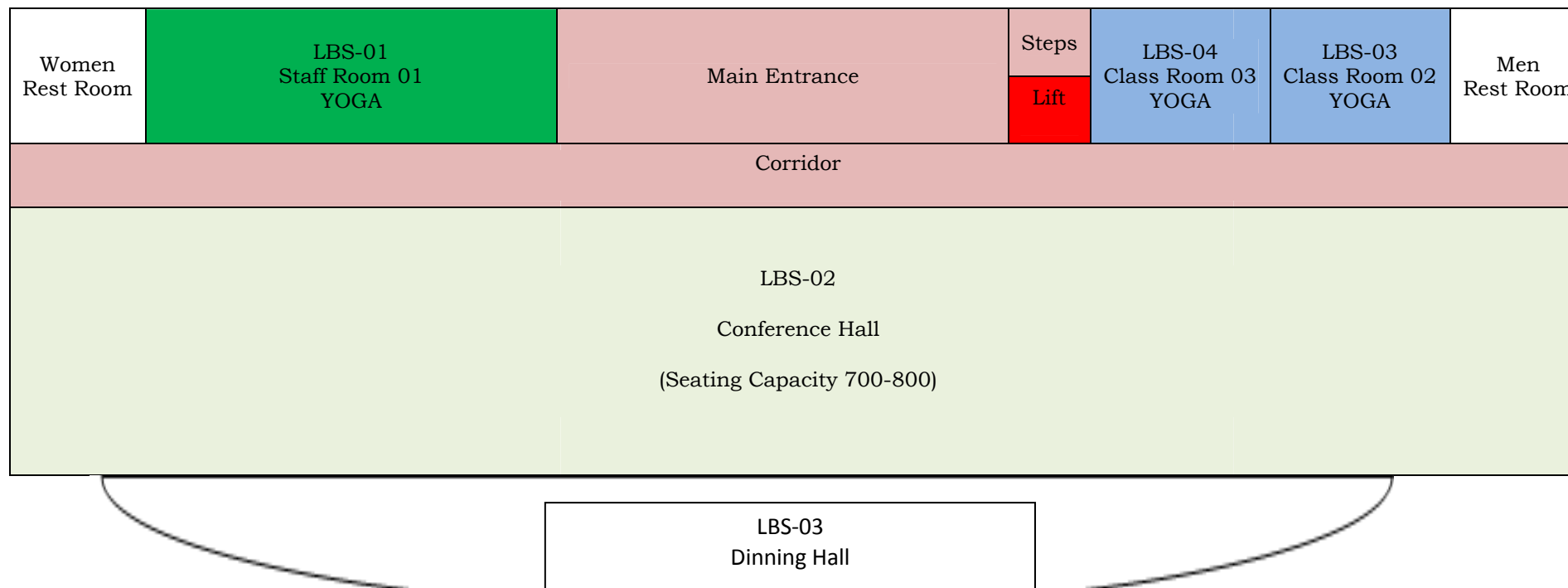
