



- 6.2. The subscribers to the memorandum shall be the founder members as well as life members of the Association and they will be known as founder - Life members of the Association. These founder life members nominated by the Patron shall be the members of the First Executive Committee and they shall hold office for a period of two academic years.
- 6.3. The Vice-Chancellor of the University shall be the Patron.
- 6.4. The Registrar of the University shall be the Ex-officio secretary of the Association.
- 6.5. Any student / scholar who pays the annual subscription of Rs. 200/-during his study in the University can be considered as student member of the Association and he / she will automatically become member of the Association after passing out from the University, taking the subscription of Rs. 200/- paid during his / her studentship as the annual membership for the first year.

7. Administration

- 7.1. The administration of the Association shall rest in an Executive Committee, consisting of (1) a President (2) a Vice-President (3) a General Secretary (4) a Joint Secretary (5) a Treasurer and (6) Eleven Members. All founder Life members shall be the Ex-officio members of the Association. The Public Relations Officer of the university shall be an Ex-officio member of the Executive Committee.
- 7.2. The Members of the Executive Committee shall be elected by the Members of the Association including Life members and founder life members at the Annual General Body Meeting (AGBM) and they shall hold office for a period of two years.
- 7.3. A committee once elected shall continue to hold office till a new committee assumes charge.

7.4. If any vacancy arises in any post on account of resignation, death etc., the Executive Committee may nominate any person to such post from among the members of the Executive Committee. Such nominated persons shall hold office till the next election of the Executive Committee.

- 7.5. If an Executive Committee Member is absent from three consecutive meetings of the Executive Committee, without prior notice, he / she shall cease to be a member of the Executive Committee.
- 7.6. If any member fails to pay the annual subscription fees with in that year (on or before the end of the academic year, ie. 30th June) after the same has fallen due shall cease to be member of the Association and the General Secretary shall remove the name of such defaulter from the register of members.
- 7.7. The Executive Committee shall have the power to expel a member for wilful disregard to the Association rules or misconduct, on provided the member concerned gives an acceptable explanation for his / her misconduct.

8. Election and Tenure of Office

- 8.1. The mode of election shall be by secret ballot.
- 8.2. The procedure for election shall be laid down by the Executive Committee.
- 8.3. All terms of office of the elected members shall commence from the close of the AGBM at which elections were held and shall continue for a period of TWO YEARS or till the close of the second AGBM leaving one in-between, whichever is earlier.
- 8.4. Members can not hold the same office for more than two terms.
- 8.5. In the event of a vacancy at any level in the Executive Committee, the Executive Committee shall have the freedom to elect a member to fill the vacancy.
- 8.6. However, notwithstanding clause third (8.3) above, the first Executive Committee, shall hold office for a term of three consecutive years for building the Alumni Association on sound footing.

9. General Body Meetings

- 9.1. The Annual General Body Meeting shall be held every year in before the 30th September.
 - a. to elect the Executive Committee
 - b. to approve the audited statement of accounts.
 - to delibrate the annual report of the Association, and

d. to consider any amendments to the By-laws.

9.2. The Executive Committee may convene General Body meetings as and when necessary.

9.3. Extraordinary meetings of the General Body shall be convened at the request of not less than one-third of the total members, within two months after receipt of such request.

9.4. The quorum of a General Body meeting shall be one-third of total members members whichever is less.

9.5. The meeting shall be conducted in the University premises.

10. Executive Committee Meetings

10.1. Meetings of the Executive Committee shall ordinarily be convened at least once in 3 months.

10.2. Special Meetings of the Executive Committee shall be convened on written request of not less than 7 members of the Executive Committee.

10.3. Quorum for a Meeting of the Executive Committee shall be one third of members of the Executive.

11. General Provisions regarding meetings.

11.1. twenty one days notice shall ordinarily be given for all meetings of the General Body / Executive Committee. The notice of the General Body meeting shall be published in two newspapers / University Alumni web site approved by the University.

11.2. In the absence of the President, the Vice-President shall preside over the meetings of the General Body / Executive Committee. In the absence of the President and Vice-President, a senior member of the Executive Committee shall preside over the meeting.

11.3. All decisions shall be on the basis of majority of votes. In case of equality of votes, the President of the meeting shall have to cast a vote.

12. Powers and Duties of the Executive Committee

12.1. The affairs of the Association shall be managed by the Executive Committee.

12.2. General Secretary and the President and at least two other members of the Executive committee shall be from amongst the members who are residents of the city of Chennai.

12.3. The Executive Committee shall have the power to incur expenditure necessary to carry out the aims of the Association.

12.4. The Executive Committee shall have the power to frame By-laws consistent with the aims and objectives of the Association. The provisional Bylaws shall be placed before the next General Body Meeting for ratification.

12.5. The Executive Committee shall have power to consider all communications addressed to the Association.

12.6. The Executive Committee shall be in charge of and protect the properties of the Association.

12.7. The Executive Committee shall prepare and submit annual reports, including balance sheets, audited accounts / statements of income and expenditure.

12.8. The Executive Committee shall collect dues / fees from members.

12.9. The Executive Committee shall undertake such tasks as will protect the objectives of the association.

13. Duties of Office Bearers of the Association

13.1Patron

 All matters of dispute shall be referred to the patron and his / her decision shall be final and binding on all parties.

13.2. President

13.2.1.1. The shall preside over all the Meetings. He / She may allocate suitable responsibilities to other executive members.

13.2.1.2. He / She may appoint working groups, sub-committees, officer, clerk and such other subordinate in consultation with General Secretary and nominate representatives of Association on vacancies, to Government / Institute and / or other bodies when invited to do so.

13.2.1.3. He / She shall act on behalf of Association.

13.3. Vice-President

13.3.1.In addition to his / her duties as a Member of the Executive Committee, he shall preside over Committee Meetings in the absence of the President.

13.4. General Secretary

13.4.1.The General Secretary shall attend to the day to day correspondence and communications to and from Association.

13.4.2. Maintain official records of the Association.

13.4.3. Be an ex-officio member of all the Committees of Association.

13.4.4. Maintain general supervision over the office staff.

13.4.5. He / She shall be responsible for calling Meetings of the Executive Committee in consultation with the President.

13.4.6. He / She shall be responsible for filing of annual Reports of Association with the Registrar of Societies after every Annual and other Special General Meetings, Financial Statements with the Income Tax Officer, and such other statutory requirements.

13.5. Joint Secretary

13.5.1. The Joint Secretary shall assist the General Secretary in discharging his / her duties.

13.5.2. He / She shall carry out such other duties as may be assigned to him / her from time to time by the Executive Committee.

13.5.3. He / She shall assume charge as General Secretary in the absence of the General Secretary.

13.6. Treasurer

13.6.1. The Treasurer shall maintain the accounts of the Association.

13.6.2. He / She will be an ex-officio member of all Committees involving financial implications and shall be the Chairman of the Finance Committee.

13.6.3. Receive and hold all moneys paid to the Association for the use of the Association

13.6.4. He / She shall be responsible for getting the audited statements of Association prepared for presentation at the Annual General Meetings and file the same with the Income Tax authorities when duly passed by the General Body.

14. Finance

14.1. Money received as membership fees, donations, subscriptions etc shall constitute the income of the Association.

14.2. The funds of the Association shall be deposited in nationalized bank(s) in the name of Association and shall be operated jointly by any two of the following Executive committee members: (i) President,

(ii) Treasurer and (iii) General Secretary duly authorized by the Executive Committee.

15. Management of Accounts

- 15.1. The Treasurer shall keep an account of the general funds of the Association. He shall maintain an account of all income and expenditure of the general funds of the Association in the manner prescribed.
- 15.2. The accounts of the Association will be subject to annual audit by a certified Auditor to be appointed by the members in the Annual General Body Meeting. The first auditor shall be appointed by the Executive Committee and He / She shall hold office upto the end of the first Annual General Body Meeting.

16. Audit of Accounts

The Executive Committee shall at least once a year submit the accounts together with a general statement of the same and all necessary vouchers upto 31st March for audit to persons appointed as auditors. The auditors shall have access to all the books and accounts of the Association and shall examine every balance sheet and annual return and other receipts and payments or income and expenditure, funds and effects of the Association and shall verify the same with the accounts and vouchers relating thereto.

17. Inspection of Books

- 17.1. The Register of Members, the Minutes Book and the Books of accounts of the Association shall be open to the inspection of any member of the Association at all reasonable hours at the registered office of the Association or at any place where the same are kept, and it shall be the duty of the General Secretary to produce the same on request by the member, free of cost.
- 17.2. Each member is eligible to be supplied with a copy of By-laws, list of members and the details of receipts and payments account, free of cost at the end of every year. Additional copy of By-laws, list of Members and details and payments account shall be supplied on application and payment of a fee of Rs.1/- for each page

17.3. The General Secretary shall file with Registrar within one month after the date of Annual General Body Meeting -

17.3.1. An authenticated copy of income and expenditure accounts, balance sheet and report of the auditors and General Secretary.

17.3.2. A statement of the names, addresses and occupations of the persons who, at the expiry of the financial year, were members of society and

17.3.3. A declaration to the effect that the association has been carrying on business or has been in operation during the financial year.

17.3.4. It shall be the duty of the Executive Committee to keep a copy of the last balance sheet of the association, together with the report of the auditors, displayed in a conspicuous place at the registered office of the association.

18. Amendments

Any of the provisions of the By-laws may be amended by 3/4th majority of the members present and voting at the General Body meeting of the Association.

19. Preparation And Filing Of Returns:-

a) Under Section 16(3) (b) Section 17(2) Section 26 and section 27 of the Tamil Nadu Societies Registration Act, all the statements and records should be prepared in time together with fees filed before the Registrar. This is the duty of the Society.

b) The Society has to convene the General Body meeting in the financial year within six months (i.e. within September 30th). During this meeting, the Societies previous financial year accounts (Assets and Liabilities) under Section 16(1) should be prepared. If the societies yearly income and expenditure is within Rs.2500/-, these accounts of the Society should be audited by two members of the General Body who have passed minimum tenth standard.

If the income and Expenditure of the society exceeds Rs.2500/- and within the limit of Rs.10,000/- the audit should be done by two graduate members who are not members of the Executive Committee but from among the members of General Body. If the income and expenditure of the Society exceeds Rs.10000/- the accounts of the Society should be audited by the Chartered Accountant under section 21(2).

The above audited accounts should be placed before the General Body to get approval. If there are no graduate members, the accounts should be audited only by Chartered Accountant and thereafter the audited accounts should be filed before the Registrar within six months.

- c) The Society has to give a declaration that according to section 16(3) (b)(iii), the previous year's functions of the Society were effectively performed.
- d) At the end of the previous financial year, the names of the members of the Society, profession and addresses in Form No. VI should be forwarded to the Registrar.
- e) During the previous financial year if there is any change in the Executive committee, such a change under section 16(3)(b)(ii) should be filed to the Registrar within 3 months in Form NO. VII along with any special resolution.
- f) It is the duty of the Secretary to keep ready for inspection for Registrar or any enquiry officer appointed by him the records, books and files of the Society according to Section 35.
- g) According to Section 34(1) and Section 34(2) after the inspection of the books by Registrar, if he calls upon the Society by Order in writing to furnish required information or explanation it is the duty of the society or committee members or members of the Society to give such information or explanation to the Registrar.
- h) According to section 36 (7), it is the duty of the member or members of the society to submit the necessary books, records, accounts and other documents required by the Registrar or enquiry officer.
- i) According to Section 13(1) of Tamil Nadu Societies Registration Act, the society should have a registered office to which all communications and notices may be addressed and as per Rule 15, the Society shall file with the Registrar notice of situation of such office.

The receipt of subscription and donation, the name of the member address, date and amount received to be signed by the Secretary or Treasurer. They should keep counter foils of the receipt books.

c. Voucher File:

The Association shall maintain vouchers containing all vouchers for contingent and other expenditure incurred by the Association, numbered serially and filed chronologically.

d. Monthly Income And Expenditure Registers:

Ledger showing consolidated and separate accounts of all items of receipts and expenditure, member-wise as well as item-wise to be maintained.

e. Letters File:

The letters should be maintained for all letters sent/Received by the Association.

f. Minute Book:

The Association shall cause minutes of all proceedings of its General Meetings, and its committee to be entered in books kept for the purpose.

g. Members Register:

The Association shall maintain a register of its members including the name, address, occupation and the date of enrolment filled in prescribed format.
